TRF Charity Work 2018-19

Dear TRF well wishers,

The Rajasthani Foundation believes in the three 'C's- Charity, Culture and Community, with charity being at the centre and pivotal to all the activities we perform. TRF has a strong charity objective to help alleviate poverty, hardship and distress amongst women, children and the underprivileged, mainly in Rajasthan by focusing on education, health and ecology.

To achieve this, TRF raises funds through various activities such as charity and cultural events as well as through donations from generous sponsors.

In previous years TRF supported multiple initiatives and charities like Navjoti Manovikas Kendra, (NMK), Jodhpur, Jagriti School, Jaipur, Sona Manovikas Kendra (SMK), Bhilwara and the Youth Trip to Rajasthan- to work closely with the children from these charities.

Last year has been a highly successful year for TRF Charitable activities and we contributed on the following initiatives and projects.

- Completed the installation of lift for the special needs' children of NMK school, Jodhpur. The lift was put into operation early this year (Feb'19). If you would remember this was possible due to support and generous donation from Sri Prakash Ji Lohia of Indorama Group in 2017.
- In partnership with OmniDe we are supporting Sapana a dream for India and as part of this we are helping raise funds for Sona Manovikas Kendra School, Bhilwara, Rajasthan to expand the dormitories for their teachers on 2nd floor. This would not only help increase the number of in-house teachers to support the students of SMK school but would also help build a strong pool of qualified & experienced teachers

who can then go out and expand the 'home based' program initiatives for children who cannot attend the school from far fledged village in Rajasthan. The budget for this initiative is £15k and so far, we have collected £1.7k. We would request all to donate generously during the evening for this noble cause.

- We continue to support the running cost for further 1 year of the school bus which takes the special need children 'to and from' the SMK School. This was possible by the donation from Shri Suresh Ji Agarwal, father of our ex TRF Director Mr Sumit Agarwal.

The above has all been possible because of the support from our Patrons, Sponsors, Members and their friends and families- so a Big Thank You to all.



In the coming year TRF plans to continue its support to NMK and SMK school to help them:

- Grow by increasing the capacity of their resident teachers by additional school building
- Increase infrastructural facility for the special need children by adding more school buses to take them to and from school
- Support the running cost of the school

The current TRF Board is very passionate about the support we as 'TRF' are providing to these schools and how it is helping change the lives of the special need children.

Navjyoti Manovikas Kendra(NMK):

- Started with 2 students 25 year ago in 1990 in Jodhpur, Rajasthan and now has a strength of 125 students and staff of 27 including 13 qualified teachers.
- 11 classes including physiotherapy centre, vocational centre, music, indoor games, interactive education class, playground equipment for young students and classes for the mild, moderate, severe, educable & non- educable groups.
- The school has in house clinical psychologist & care givers.
- Providing educational, vocational training & rehabilitation to the special (mentally handicapped) children of Jodhpur.
- The school has a Govt. Of India RCI approved college for 2 years diploma in mental retardation D.Ed. (MR) course with 60 students. These students interact daily with the MR children on 1:1 basis as a part of their curriculum.
- The school also has visiting psychologist, speech therapist and neurologist.
- This is the only fully equipped school in this region for MR students

Sona Manovikas Kendra(SMK):

- An exclusive school for Mentally Disabled Children, Non -Aided & Public Co-operative Institute.
- It is run by "Sona Viklang Punervas Avom Sodh Sansthan , Bhilwara" institute since 1996.
- It is the only school in Bhilwara District empowered to deliver these special duties.
- Presently there are 65 students get free education, training, physiotherapy, speech therapy which is provided by school.
- Every year more than 50 non-admitted children are benefited by providing special "Home-Based" program.

Rajasthani Food – Khichda and Imlani

Akshaya Tritiya or Akha Teej is an annual springtime festival for Hindus and Jains and signifies the 'third day of unending prosperity'.

Traditionally, on this day, we don't cook things which need a knife to cut, but use whole foods, hence the name Akha, or whole.

This is a recipe for an unusual dish cooked specially on Akha Teej but tastes good any time of the year.



Ingredients

1. One cup wheat, with no skin
2. One tablespoon whole green mung
3. Salt
4. Ghee
5. Tamarind
6. Sugar
7. Powdered cardamom

1. Mix the wheat and dal in a pressure cooker with 4 cups water, salt and cook for 8-10 whistles.
2. Open the cooker and cook for another hour using very low flame.
3. Keep stirring so that the mixture does not stick onto the bottom.
4. Now comes the ghee! Mix half a cup of ghee and stir until the mixture turns a light colour.
5. The grains should not be visible separately by now, but mixed.
6. If the chichda is too thick, add a cup of water and keep stirring.
7. Serve boiling hot with ghee and imlani.

Imlani

1. Soak some tamarind/imli in 2 cups of water.
2. Soak 1 cup sugar in about 4 cups of water.
3. Mash the tamarind with your hand and strain the water.
4. Mix this with the sugar water and cool it with ice or keep in fridge.
5. Add some cardamom/ilaichi powder into the imlani.
6. This is a very refreshing drink to accompany khichda.

Structure:

The Rajasthan Foundation (TRF) is registered with Charity Commission of England and Wales and listed as company by guarantee without share capital at Companies House England and Wales.

Objectives:

- Relief of poverty, hardship and distress among members of Rajasthani Community.
- To educate and promote the Rajasthani culture within UK, including its history, language, literature, art, music and dance forms.
- Financial assistance to schools or educational establishment in Rajasthan which are in need of essential educational supplies or facilities.

Vision:

TRF aims to be a premier and prestigious organisation with a strong brand equity to be led by a team of diligent, selfless and enterprising volunteers who will nurture the objective of TRF's ambitious vision and take it to further heights. In addition it aims to support various communities in UK from various regions of Rajasthan and integrate them to support and promote Rajasthani art, music, culture, history and language.

To foster charity within the Rajasthani community and help raise funds and assist indigent schools, educational establishments and contribute to society.

Achievements

Community:

- Since 2005, TRF has increased its awareness across UK and increased its membership base to over one thousand members.
- TRF has been organising annual events such as Holi, Diwali and summer cricket.
- TRF has organised various other cultural events in last eleven years to generate community camaraderie.
- TRF is deeply rooted in the soils of UK as board members and volunteers work tirelessly for social integration of the members, which reflects in its growing membership numbers.
- TRF organized first of its kind Youth Talk at London Business School in September 2017 for our youth and young ones and that was house full. It was very inspirational and everyone is looking forward to the next Youth Talk in the series.

Culture:

- TRF organised a successful Youth trip to Jodhpur and Jaipur in 2016 for our Youths to learn more about the culture and history of Rajasthan.

Charity:

- TRF has been working since its inception to promote charity and organising flagship charity fund-raisers every year to support causes in Rajasthan.
- Since day one, the organisation has been working with zero administrative costs, with unconditional support from the board of directors and volunteers.
- TRF has supported Navjyoti Manovikas Kendra (NMK), Jodhpur with funds to construct new buildings, improve its infrastructure and facilities. NMK is a Jodhpur based educational charity that provides specialist education to children and young adults with special mental, physical and behavioural needs.
- TRF supported Jagriti, a charity based in Jaipur to rebuilt a derelict and abandoned school in slum area of the city to provide education for the local children.
- TRF has organised 'nearly used' clothes collection in UK amongst members for distribution to needy children via chosen charities.
- TRF board is always looking for opportunities to support various causes and charities in Rajasthan or helping the needy directly where possible and for this it invites its members to come-up with innovative ideas to help.

Vision for 2022

- TRF would like to dream big and take a step in the direction of having a purpose built building of its own. A place to call home. The board members feel it should be self sustainable and eco friendly. It would house a office, community areas, banqueting facilities to hold events.
- TRF will continue to increase its membership and encourage people of Rajasthani heritage and connections to come together from across UK and EU.
- There are around 8-10 small Rajasthani groups and organisations in UK. TRF would like to work in conjunction with them, to support an inclusive Rajasthani community in the UK.
- TRF aims to increase its membership base by 50%.
- TRF's plans to continue, to preserve Rajasthani culture and heritage for future generations within UK by establishing a TRF Community Centre by 2022.
- TRF aims to run two annual events, and one youth programme every year. Under the Youth programme initiative it will explore various possibilities like charity trips, series of inspirational talks, and showcasing young talent at its annual events.
- In near future TRF intends to help build new schools or provide support to existing schools in need of essential educational facilities. TRF targets to donate the sum of £150,000 in next five years. TRF intends to expand its charitable arm to other deserving causes in Rajasthan and in UK where appropriate.
- In UK, TRF will continue to provide a strong social, cultural and professional platform to its members and especially to its youth.







Divine Simplicity Code of Conduct

Lord Vishnu made Mother Lakshmi the Swamini of wealth-property. He did not consider Himself suitable for the job and give this task to Mother Lakshmi. The Lord knows that a woman can appropriately manage family with discipline and co-ordination. She can control over wasting money. Bhakta Pahlada, his son and grandson etc., did not use public money in personal matters; therefore, Mother Lakshmi was always happy. Mughal Emperor Aurangzeb was a fundamentalist, but he did not use state money for his personal tasks. The wealth in the world is the Prasada –gift given to us by Mother Lakshmi. 

The Nearly New Clothes Project

What is The Nearly New Clothes Project and what do we do?

The Nearly New Clothes Project's main activity is to collect children's clothes in good condition that are no longer required by families in the UK and donate them to orphanages in India. The project was initiated in 2015 by the TRF youth.

Why re-using clothes is environmentally and socially beneficial

When clothes are thrown away, they end up in landfills. As most clothes are made of organic materials, they decompose in the landfills due to micro-organisms, these micro-organisms release CO₂, a greenhouse gas, which contributes to global warming and climate change. By reusing and donating old clothes they can be kept out of landfills.

Making clothes also requires large amounts of energy which is usually obtained by burning fossil fuels, this releases greenhouse gasses; reusing clothes means that less clothes need to be made and if less clothes are being produced, less energy is being used.

Additionally, donating clothes means that the children receiving them are provided with clothes and the orphanages can focus on providing the children with food and shelter rather than having to worry about clothing the children.



How you can help

Young families have children that outgrow the clothes in just one season, which means most clothes (winter or summer) are used a few times only. There are a lot of families in UK who would like to dispose these old clothes in a way that they can make a positive impact to the environment and also help underprivileged families in India. To keep the project alive, we need your help.



Sapana, A Dream for India

The Cause

Omnide in partnership with The Rajasthani Foundation and IMA Foundation is proudly supporting the development of the Sona Manovikas Kendra for mentally challenged children in Bhilwara in Rajasthan, India and to give them a future that would otherwise be neglected.

Run by the “Sona Viklang Punervas Avom Sodh Sansthan” Institute since 1996, it is the only school in Bhilwara District to empower its special duties. Presently 65 students get free education, training, physiotherapy and speech therapy. Every year more than 50 non-admitted children benefit through a special “Home-Based” program. The school has the opportunity to host more children but in order to do this requires to build more dormitories for its teachers.

The Event

Omnide has hosted a special event on the 3rd of July 2019 with the support of TRF and IMA Foundation that have

been showcasing and selling on the evening, the works of six Indian artists has brought us closer to our aim; to build a better future for mentally challenged children by giving them the opportunity of learning and overcoming their disability with the help of skilled teachers. Currently, the children live on the street or at home without the possibility of engaging with others and the space around them.

Together with the members of the TRF (The Rajasthani Foundation) such as Dinesh Choudhary, Rajesh Chechani, Varsh Dahad, we were happy of the appearance of about 90 people that came to support the cause for the children and to celebrate the art by six Indian artists.

Omnide began the night by introducing the cause explaining that the purpose of the event is to raise money to fund the development of the second-floor extension of Sonas Manovikas Kendra School that will be designed by OmniDe.

The funds raised will be dispersed and monitored in India by The Rajasthani Foundation.

The Deputy Major of London for business, Rajesh Agrawal also came to support the event and shared kind words about the charity. Both the artists, Harshita Lohia and Radha Binod Sharma gave their speech, explaining what their artwork is about, their experiences and the importance of the charity event.

The Project

In the previous year, The Rajasthani Foundation have already been involved in developing the school by building an activity hall.

Following TRF’s requirements, for the first phase of the project Omnide has proposed to build a dormitory on the second-floor extension is to bring more teachers in the institution allowing more job opportunities as well as giving the chance to empower more disabled children through education.

By enhancing the capabilities of the school, we will be able to work towards reducing the social stigma faced by these children and provide them with greater self-confidence and the chance of a better future - being independent and self-supporting.


Each room will have space for a single bed, a desk and a wardrobe. The extension also includes facilities such as two shared bathrooms and communal areas where teachers can relax or socialize such as space for dining and balconies.

The angled brickwork of the facade is designed to allow privacy for the teachers, the openings of the balconies as well as subtly bringing natural light

through these gaps that acts like stainless glass when reflected on the ground. The play with light of this detailed element will create a joyous threshold through the corridor that also portrays the colourful culture of India.

The success of the charity project will allow us to help the school:

- Cater to the needs of an additional 80 vulnerable students from nearby villages
- Extend the second-floor level to build dormitories for teachers, providing more teachers per student and improved teaching facilities,
- Increase the school’s overall intake of students.
