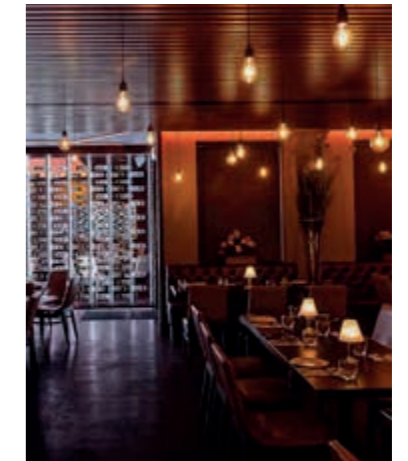

Made it all so worthwhile.

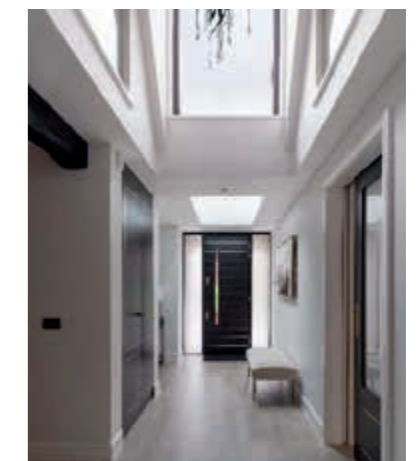

# TRF Charity Work 2020-21

## TRF INDIA COVID RELIEF

### (Distribution of 822 Oxygen concentrators and non-evasive ventilators)

In 2020, when the Covid cases peaked in the UK, the social distancing and temporary separation from families had a far-reaching impact on our elderly especially those staying at care homes.

TRF realised the immediate need and launched the 'Connecting Elderly@ carehomes with Families' campaign. We delivered more than 70 electronic tablet devices to the Care Homes in London.

Due to overwhelming response we continued the campaign in June 2020 and further delivered electronic devices to various care and nursing homes around London.



In April 2021, when deadly second wave spread from cities to small towns and brought India on its knees where over 100,000 people died in just 40 days. Hospitals ran out of beds and life-saving oxygen and beds during the second wave. We were getting pleas from the head of hospitals, patients and their loved ones requesting for the supply of liquid oxygen in the hospitals.

In response, we setup a 'TRF INDIA COVID RELIEF FUND' to help the government hospitals in the Rajasthan where oxygen concentrators were most needed. In the first phase, we bought and shipped 20 oxygen concentrators to Mahatma Gandhi hospital in Bhilwara and later, 32 oxygen concentrators and 14 non evasive ventilators to Government Medical College Ajmer which were deployed in the Covid ward.

TRF team directly coordinated with the government officials including Chief medical Officer, Deputy Collector and Collector, it was heart wrenching to hear the disastrous situation on the ground directly from government officials.

TRF worked hard and ensured that **over 756 oxygen concentrators** were shipped to different hospitals in the Rajasthan to save precious lives. This part of the operation was done with the doctors from Rajasthan Medical Alumni Association Inc who were already working on the ground level.

## Rajasthani Malai Bhutta

### INGREDIENTS

1. 2 full bhuttas (corn on the cob)
2. 500 ml cream or malai
3. Fresh yoghurt or dahi 1 cup
4. Hing, salt, haldi (turmeric) powder, dhaniya (coriander) powder, pisa jeera, (cumin powder) mirchi (red chilli) powder, oil
5. Khada masala like laung, elaichi, dalchini, tej patta, sabut lal mirch, saunf, jeera
6. Kasuri methi, green chilli sliced lengthwise, grated ginger (2 tsps) and fresh cut dhaniya patti

### METHOD

1. Cut the corn lengthwise and then into small pieces, boil in a saucepan with water and half tsp of salt.
2. Meanwhile, put another saucepan to heat, add a generous amount of oil. When hot, add your chunk of hing and all the khada masalas.
3. Beat and smoothen the yoghurt with a fork, add some red chilli powder, grated ginger and sliced green chillies to the chunk and then pour the beaten yoghurt into the mix.
4. Stir continuously for few minutes on a medium flame until the oil separates from the yoghurt mix. Add the dry masalas like turmeric powder, 2 heaped teaspoons dhaniya powder, salt to taste and 1 teaspoon pisa jeera.
5. Now add the cream, increase the flame and stir until the mix comes to a boil.
6. Reduce the flame and add the boiled bhutta pieces, toss in some kasuri methi and a handful of chopped coriander leaves. Save the water from the corn.
7. If the mix is thick, add some water from the boiled corn and keep stirring gently for another 5-7 minutes.
8. Voila! Malai Bhutta ready! Can eat with rotis, parathas or pooris. The corn absorbs the gravy and is very tasty on its own as well.

# Besan Chakki-in Rajasthani style

My mum always makes this sweet for Diwali & it takes me to my childhood memory lane.

## INGREDIENTS

250 gm of Besan  
200 gm of sugar  
200 gm of ghee  
100 gm Mawa/Khoya  
Saffron threads- for natural color  
Fine cardamom powder  
Grated nutmeg  
Fine mace powder  
Almonds & Pistachios for decoration  
2 teaspoon of milk

## METHOD

First make sugar syrup. Mix 1/2 cup water and all the sugar in a pan and make one taar chashni. Add Saffron for natural color and the cardamom powder in it.

1. Take 250gms besan, add 2 tsp milk and 2 tsp melted ghee to it and make tight dough.
2. Now make small balls of this mixture.
3. Add ghee in pan and fry besan dough balls on medium flame till golden.
4. Cool them for a while and chop them into small pieces.
5. Grind them to make coarse powder.
6. Heat ghee in a pan and bake the coarse besan mixture on low flame until it browns & smell the aroma.
7. Now put grated mawa in it and bake for 10-12 minutes, stirring continuously.
8. Add freshly grated nutmeg and fresh fine mace powder (it will give chakki a very nice aroma)
9. Now cool the besan mixture for 20 mins & add lukewarm chasni / sugar syrup in it. (if you put it in hot mixture it will turn into halwa)
10. Leave it for 10 mins and let mixture soak the chasni.
11. Grease the tray & set the besan mixture in it.
12. Now put the pure silver foil on it. Sprinkle soaked saffron, almond pistachio on top.
13. When it is cold, cut into desired shape and serve.

*Tips If you want to apply silver foil, you have to apply it on hot chakki.*

# Do you need to think about inheritance tax?

*"Inheritance Tax; - it is, broadly speaking; a voluntary levy paid by those who distrust their heirs more than they dislike the Inland Revenue"*

- Roy Jenkins, Former Labour Chancellor



Inheritance Tax (IHT) is a tax on the estate of someone who has died, including all property, possessions and money. As you pass on your assets or money after you die, your heirs could face a tax bill of up to 40% of the portion of your estate above the threshold.

For example, if your estate's worth is £1,000,000 and you get a tax-free threshold of £500,000, your estate will pay HMRC £200,000.

## You can reduce or avoid IHT in a number of ways

The best way to reduce inheritance tax on estate is to spend your money while you can!

There's a tax-free allowance, and you can also give away a certain amount of your money during your lifetime, tax-free and without it counting towards your estate. Most common ways to reduce your estate:

- Gift your assets away (7-year rule)
- Put your assets in a trust (properly executed, you can even put your assets into a trust and still earn an income)
- Distribute excess income

Generational Inheritance Tax is a reality for most in the UK wherein money is taxed as it is inherited through the generations.

In essence, this means that your children, and even your grandchildren, may be required to pay additional inheritance tax on money that you've already paid your 40% inheritance tax on!

This will normally be the case if you and your spouse have standard wills.

## IHT: A tax on ignorance

Figures requested by Canada Life as part of a freedom of information showed estates worth £10m or more paid only 10 per cent IHT on average!

## Last Will and Testament & Estate Planning

Your Last Will and Testament (Will) is the most important part of the estate planning process that contains details about how you wish your assets to be passed on after your death, who



are executors of the will and if you have minor children, the Will describes who will take care of them.

In case you don't have a Will, it might get tricky to sort your estate out...for instance If you're assuming that your spouse will inherit all your wealth, then it's not the case as per 'intestacy rules'

Estate planning goes beyond the standard Will and is all about finding a way to pass on your assets to the next generation most effectively by lowering Inheritance tax. The estate plan will contain your Will, trust deeds, memorandum of wishes and nominations/assignments of insurance and pensions.

## Trusts and how are they used

Trusts are one of the most valuable financial planning tools, but they are also one of the least-well understood.

Trusts are used as a vehicle to pass on wealth to children and grandchildren in a tax efficient manner. The trustees retain control over where the assets are invested and how much is paid out of the trust, but they will only have the option to pay out to designated beneficiaries.

While there are many types of trusts, the vast majority in use are discretionary trusts. These trusts have a class of beneficiaries defined such that they can benefit from the assets but the assets are not considered part of their estate, thus protecting the beneficiaries from IHT, divorces and other attacks

The law of trusts first developed in the 12th century from the time of the crusades.

When a landowner left England to fight in the Crusades, he conveyed ownership of his lands to a friend to manage the estate and pay and receive feudal dues in his absence, on the understanding that the ownership would be conveyed back on his return. However, Crusaders often encountered refusal to hand over the property upon their return. Unfortunately, the English common law did not recognize his claim.

The law was changed and the legal owner would hold the land for the benefit of the original owner, and would be compelled to convey it back to him when requested. The Crusader was the "beneficiary" and the acquaintance the "trustee". And so, TRUSTS were born!



# TRF Charity - Ambulance Donation

## Charity Initiative during Covid 19

In April 2020, when Covid peaked in the UK, TRF decided to do its 'bit' to appreciate, motivate and respect the NHS and the unsung heroes. TRF has shown its gratitude to both. We worked with the Hillingdon Hospital's food bank team and helped them set up the food bank for the NHS staff by donating the dry supplies.

TRF also acknowledged the unsung warriors in the front line of our daily lives. We served a hot thank you lunch to the staff of Sainsbury's Stanmore branch. It was an expression of gratitude for service our community in these challenging times by making sure we had food on our tables.

In 2021, India suffered with deadly Covid wave 2. This resulted in high number of casualties, people were left with no choice but to bring their loved ones for last rites in auto-rickshaws and private cars due to a shortage of ambulances in the whole country.

TRF identified Young Indians (YI) which is a not-for-profit organisation and is playing a proactive role in India's development process.

Young Indian has their presence in 55 city's chapters in 24 states and 4 union territories across India and has been doing significant charity work across the nation.

YI were desperately trying to help patients and hospitals with the resources that they have available and showed immediate desperate requirement of an ambulance.

Team TRF considered this request and helped secure funds for the purchase of an ambulance called "Farishtey" to help patients in the desperate times. Post wave 2 now the ambulance is being used to help patients in the remote areas.

The decision was taken to ensure that the people in desperate needs do not have to wait for the treatment and to save lives in future.
